## The Associates of NCCW, Inc.

Associates of NCCW, Inc. is an individual membership organization designed for Catholic women and clergy who wish to strengthen their support of the National Council of Catholic Women.

## Foundation

The Associates of NCCW, Inc. was founded in 1970 to support and encourage religious, educational, civic, and charitable projects within the National Council of Catholic Women framework.

## Structure

Bylaws were adopted by the first Board of Directors of the Associates, Inc., on October 16, 1970. The Articles of Incorporation were adopted, notarized, and filed in the District of Columbia as a nonprofit organization. The bylaws, standing rules and articles of incorporation govern the organization. It is managed by a Board of Directors consisting of four (4) elected officers, the immediate past president, and eleven (11) elected board members.

## Meetings

At each Annual Convention of the National Council of Catholic Women, a meeting of the Associates present is held to conduct business at hand. A board of directors meeting is held every year.

## Membership

Any Catholic woman who is a member of the National Council of Catholic Women or clergy who subscribe to its goals shall be eligible for membership.

**Provisional Members** pay an initial fee of \$15 to join and dues of \$15 a year to be paid in February. When members have paid a total amount of \$50 through the initial fee, dues, and donations, they become Active Members with voting privileges.

**Active Membership** is attained by an initial or accumulated payment of \$50. Active members have voting privileges and are eligible to be elected to the Board of Directors.

**Life Membership** is reached when the member has paid a total of \$500 through dues and donations. The Life Members are entitled to full participation and are no longer required to pay annual dues, but donations are appreciated.

### **Additional Levels of Giving:**

Members achieving additional levels of giving will be recognized at the annual meeting. Leader (\$1,500) Silver (\$2,500) Gold (\$5,000)

## Grants

Funds raised by the Associates through dues and donations each year are used for grants to the National Council of Catholic Women. These funds have been used for projects/programs such as brochures, Legislative Alerts, Bulletin Boards, Catholic Women inserts and other needs. Members or Donors may deduct contributions to the Associates as provided in Section 170 of the Internal Revenue Code.
