Board members are required to answer an annual conflict of interest questionnaire and to report any potential conflicts of interest involving NCCW as they arise. Staff employees sign a conflict of interest agreement upon hire and are required to report potential conflicts of interest involving NCCW as they arise.

NCCW posts its bylaws on its website (www.nccw.org). NCCW makes its other governing documents, conflict of interest policy, and audited financial statements available to the public upon request.
